# Please Read and Sign:

**Stall Application Terms And Conditions** This stall application is not a lease of any space, but is merely a revocable license or permit on the terms outlined below. All stable reservations and entries in stakes and other races are received and accepted subject to all conditions, rules and regulations of the Wyoming Pari-Mutuel Commission and Wyoming Downs. No stable reservation or entry in any race will be received except upon the condition that all disputes, claims and objections arising out of the racing or with respect of the interpretation of any rules or conditions of races or otherwise shall be decided by the Wyoming Pari-Mutuel Commission, the Board of Stewards, the Association or Management, and such decisions shall be final. Wyoming Downs reserves the right to cancel any stakes race or other race prior to the actual running thereof, without liability, except for the return of nomination and entrance fees. Wyoming Downs reserves the right to refuse entry in any race or admittance to the grounds, any person who may be deemed as detrimental to racing. Wyoming Downs reserves the right to produce or exhibit still or motion pictures, radio, photographs, television programs or authorize others to make or exhibit the same of certain races and related events occurring prior and subsequent to running of said races. The acceptance of stall accommodations or making an entry in any race shall mean that the trainer grants his consent to the above condition without remuneration, and that the applicant has secured like consent from his/her owner, jockey, groom, agents and associates connected with his/her racing activities, and consents upon demand to deliver to Wyoming Downs such consent of any aforementioned persons permitting it to use and exhibit such material. It is a requirement that all horses listed on this application are in good health and will be accompanied by a current Coggins Test before being allowed on the grounds. It is also required that all horses listed will be ready to race upon the opening of the race meeting. This application does not guarantee stalls will be allotted, nor does it guarantee that tack rooms or walker space will be available. If you wish to have a tack room or walker space, please indicate such in the appropriate place. Workmen's Compensation: Wyoming State Law requires that all owners and trainers shall carry Workers Compensation Insurance covering all of their employees. This paragraph is intended to include all individuals employed by owners and trainers in the training and racing of their horses. Use of golf carts or ATVs in the barn area may be restricted if right of use is abused in any way. Children under the age of 16 years ARE NOT to operate golf carts or ATVs in the stable area at any time. Wyoming Downs is not liable for injuries or accidents when riding in such vehicles. **No loose dogs are allowed in the barn or track area. Dogs are allowed in trailer park on leashes only. Barking dogs will not be allowed on the premises!**

**Important Notice** In making this application for stalls, the signer hereby agrees to stable and race approved horses during the entire season. If, for any reason, the signer intends to vacate the allotted stalls and race elsewhere prior to the end of the season, the signer must notify the Racing Secretary at the time of application. In consideration of and as a condition of the privilege for permission to stable on the premises of Wyoming Downs for the purpose of racing horses, I agree to all provisions set forth herein as follows: 1. To abide by all rules of Wyoming Downs pertaining to stabling. 2. To vacate the stalls and move all horses, equipment and personnel from Wyoming Downs within three (3) days after being requested to do so. 3. That Wyoming Downs will not be liable or responsible for any injury or loss suffered in any manner by or to the horse(s), equipment or personnel of the undersigned while on or off the premises, whether caused by the condition of the premises, by negligence or otherwise. For your protection it is requested that you insure your horses and equipment against loss by fire. Wyoming Downs Racetrack assumes no liability for loss of horses or equipment by fire. 4. To hold Wyoming Downs free and harmless from all loss, costs, damage liability or attorneys' fees which may be asserted against it by the undersigned or by any other person(s) whether or not employees or agents of the undersigned at Wyoming Downs or other approved stables or by reason of any conduct or negligence of the undersigned or any of his employees or agents.

**Release:** The signer hereof represents that he and all persons for whom he is acting have read and are familiar with Wyoming Downs Rules of Racing and the regulations of the Wyoming Pari-Mutuel Commission and the race meeting conditions and agrees to be bound by and comply with the same and the acts and decisions of the Wyoming Pari-Mutuel Commission and the Racing Officials and acknowledges that the decision of the Stewards shall be final in all matters.
