Our RV Parks are equipped with power and sewer hook-ups. Payment is due upon arrival and payable at the Race Office. No prorating is done. Rates will be deducted from your account if not paid in full.

RV Park Use and Payment Policy

Payment is due upon arrival and is payable at the Race Office. Any unpaid RV fees may be deducted from the trainer and/or owner horsemen accounts. Failure to pay RV fees in full may result in the denial of future RV space assignments and may also affect eligibility for future stall assignments.

General Horsemen RV Spaces & Public Campground: The general horsemen RV spaces located in the front campground, which provide electric-only hook-ups and the public campground, with no services, through the Wyoming Downs website at www.wydowns.com. These spaces are open to the public, subject to availability, and are administered separately from horsemen RV assignments.

Horsemen RV Assignments: Horsemen RV assignments will be made directly to Wyoming Downs management. Wyoming Downs management reserves the right to reassign any RV space if a trailer is removed from the grounds or vacated at any time during the racing meet. Horsemen do not have the authority to transfer, lend, sublease, or otherwise assign their RV space to anyone. Wyoming Downs RV Parks designated for horsemen are equipped with full hook-ups, including power and sewer. RV space fees are billed on a weekly basis and invoiced monthly, regardless of occupancy. If an RV or trailer is parked in an assigned space, charges will apply for the duration of time the space is occupied, whether or not the RV is actively in use.

Any trailer that departs the RV park without prior notification to the Race Office may forfeit its assigned space. Trailers returning after departure should not assume availability of the same space, as it may have been reassigned. Wyoming Downs will not hold RV spaces for unattended or unreported departures.

Free RV and Dry Camping Area Use Policy

A designated free RV and dry camping area may be available for limited use. Use of this area is restricted to Wednesday through Sunday only. Any trailers or vehicles remaining in the free RV or dry camping area on Monday or Tuesday will be required to vacate the premises. Failure to vacate during restricted days may result in towing, removal, loss of camping privileges, or loss of access to Wyoming Downs property, at the discretion of management. This area is intended for short term, temporary use only and is not authorized for extended or continuous occupancy.

No open fires are allowed at any campsite. Wyoming Downs is not responsible for any theft or damage to vehicles or its contents.

The undersigned (on my own behalf and on behalf of my heirs, family, friends, invitees, personal representatives, successors and assigns), for and in consideration of the opportunity to rent a Campsite at the Wyoming Downs Racetrack (hereinafter, Campsite) owned by Owner, its affiliates and advisors, officers, directors, members, employees and agents (hereinafter, each a "RELEASED PARTY," and collectively the "RELEASED PARTIES") the undersigned hereby releases and holds harmless the "RELEASED PARTIES" from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the "RELEASED PARTIES" in any way resulting from, arising out of, or in connection with my stay at the Campsite.

This Release extends to any and all claims I have or later may have against the "RELEASED PARTIES" resulting from or arising out of my occupancy whether or not such claims result from negligence on the part of any or all of the "RELEASED PARTIES" with respect to my occupancy or with respect to the conditions, rules or procedures under which my occupancy is allowed or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY "RELEASED PARTY" FOR ANY INJURY RESULTING TO MYSELF (OR OTHERS) OR DAMAGE TO MY PROPERTY (OR THE PROPERTY OF ANY THIRD PARTY) ARISING FROM, OR IN CONNECTION WITH MY OCCUPANCY AT THE ABOVE RESIDENCE OR FROM THE DUTIES OF ANY OF THE RELEASED PARTIES IN OWNING AND/OR MAINTAINING THE ABOVE RESIDENCE.

I agree to pay, indemnify, defend and save harmless, the "RELEASED PARTIES" from all suits, actions, claims, demands, damages or losses, expenses, and/or costs of any kind and description, including, but limited to attorney fees, settlements and/or judgments, to which the "RELEASED PARTIES" may be subjected to by reason of injury, (including death), to any person(s) or destruction of property, including loss of use resulting there from, in connection with, or growing out, of any act of commission or omission of the Undersigned, my friends, family, invitees, attendees, associates, and the like, or any person dealing with me in any way in the use of or on/at the campsite or from any events that take place at or around said residence. Notwithstanding the fact that any of my liability to the "RELEASED PARTIES" may be covered by my personal insurance, I acknowledge and understand that my liability shall in no way be limited by the amount of the insurance recovery or coverage. I also acknowledge, warrant and understand that I am in no way covered by any insurance of the Owner, nor covered by any other insurance that the Owner may have.
